

Manpower Requirement

Ramsar Convention came in to force globally in 1975 and it became operative on 01.02.1982 for India. Consequent upon the adoption and signing of Convention by India, the Wetlands (Conservation & Management) Rules, 2010 under the Environment (Protection) Act, 1986 have been notified to set up a regulatory mechanism for wetlands across the country in consistent with the Ramsar Convention so as to maintain the ecological character of wetlands and develop national inventory of wetlands

For the purpose of identifying, notification and regulating the wetlands, Central Wetland Regulatory Authority (CWRA) has been constituted under the Rule 5 of the said Wetlands Rules, 2010. Secretary, Environment, Forest and Climate Change happens to be *ex-officio* Chairman of CWRA. Said Authority is required to scrutinize the proposals of State Governments/UTs while objections/suggestions of Public/NGOs/Stakeholders on the proposals by State/UTs are required to be handled before notification and other works related to Wetland Rules, 2010.

Under the Sustainable Development Goals (SDG), sub-goal nos. 2.4, 6.4, 6.5, 6.6, 11.5, 12.2, 13.1, 14.2, 15.1 and 15.3 are associated with wetlands. CWRA cell is required to address said sub-goals, as well.
